DEFINED TERMS

In these Promotion Terms and Conditions:

“**Bonus Gift**” means the Prezzy Card amount identified in Table 2

“**Claimant**” means an individual that has met the Eligibility Criteria.

“**Participating Retailer**” means the following retailers:

“**Participating Product**” means the Samsung products identified in Table 1.

“**Promoter**” means Samsung Electronics New Zealand Limited, 24 The Warehouse Way Northcote Auckland.

“**Promotional Period**” means the period between 1:00am on July 23 2026 until 11:59pm on August 31 2026.

1. Participation in this Promotion is deemed acceptance of these Terms and Conditions.
2. The Promotion is only open to New Zealand residents who have:
 - a. Purchased a Participating Product from Table 1 from a Participating Retailer during the **Promotional Period**. (“**Eligibility Criteria**”).
3. Employees (and their immediate families) of the Promoter, the Promoter's New Zealand branch office, Participating Retailers, and agencies associated with this promotion are ineligible for this promotion.
4. Limit of one claim per customer. Each eligible customer may submit a maximum of one claim and any additional claims submitted by the same customer will be deem invalid.

HOW TO CLAIM

- Bonus Gift is not available at the time of purchase. To claim the Bonus Gift, claimants must: Purchase one of the Participating Products between 1:00am on July 23 2026 until 11:59pm on August 31 2026.
 - Visit <https://www.galaxywatch2026.samsungnz.com/>
 - Register their claim before 23 October 2026 by submitting the online redemption form and the details of their claim including:
 - the claimant's full name, physical address, email address and phone number;
 - the participating retailer and store from which the Participating Product was purchased;
 - the invoice details and the serial number of the Participating Product;
 - upload a copy of the proof of purchase and a photo of the serial number, then click submit.
- Once the claimant takes delivery of their Participating Product, the claimant must register their claim no later than 23 October 2026. Any outstanding claims for which the Promoter has requested additional information or documentation must be completed by 23 January 2027. Claims that remain incomplete after this date will not be accepted by the Promoter.
- A physical Prezzy Card shall be issued and dispatched to the claimant's nominated postal address only after the claim has been satisfactory verified and approved. Verification and approval may take up to 2 weeks. Delivery of the Prezzy Card is expected within 20 working days.
- The Bonus Gift may be fulfilled as one or more physical Prezzy Cards. Where multiple Prezzy Cards are issued, the combined value of those Prezzy Cards will equal the advertised Bonus Gift value.
- If the serial number and the proof of purchase do not match the details submitted by the claimant, the claim will be deemed invalid and will result in an ineligible claim. The eligible Claimant will not be entitled to receive the allocated Bonus Gift until the Promoter has received the required documentation and verified the claim.

6. The Promoter reserves the right to reclaim from any claimant, the relevant Bonus Gift; if the initially purchased Participating Product is returned after the claim has been processed and fulfilled. This clause does not limit or affect the claimant's rights with regards to warranties on the Participating Product either from the manufacturer or implied by legislation.

GENERAL TERMS AND CONDITIONS

1. The Promoter reserves the right, at any time, to verify the validity of claims and Claimants (including a Claimant's identity, age and place of residence) and to disqualify any Claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.
2. Claimants must retain proof of purchase. Failure to produce proof of purchase for each claim when requested may, in the absolute discretion of the Promoter, result in invalidation of a Claimant's claim or entries and forfeiture of any right to a Bonus Gift.
3. In the event of any disputes in relation to entries online and identification of the person making the redemption by email the Promoter reserves the right to award the redemption to the email account holder.
4. The Promoter's decision is final and no correspondence will be entered into.
5. All Claimants agree that by providing information and entering the Promotion, that they have read and agreed to these terms and conditions before any Bonus Gift is provided to them.
6. Any cost associated with accessing the promotional website is the Claimant's responsibility and is dependent on the Internet Service Provider used.

(f) use of the relevant Bonus Gift.

12. Nothing in these Terms and Conditions is intended to exclude, restrict, or modify a consumer's rights under the Consumer Guarantees Act 1993. These Terms and Conditions must be read subject to those statutory provisions and will not affect any statutory rights that a claimant may have in relation to the return of any products within the Participating Product or relevant Bonus Gift.

The Promoter collects personal information in order to conduct the offer and may, for this purpose, disclose such information to third parties, including, but not limited to, agents, contractors, service providers, offer suppliers and as required, to New Zealand regulatory authorities. Validity of a claim is conditional on providing this information. All claims become the property of the Promoter.
